- b) Office for International Exchanges for outgoing mobility;
- c) Office for International Exchanges for incoming mobility;
- d) Office for European and International Research.

Although working in close synergy, each office has its own priorities, from defining the strategic lines for internationalisation processes (a) to favoring adequate support to both outgoing (b) and incoming mobility (c) and supporting the incoming and outgoing mobility of teachers and researchers for research purposes.

In January 2009, the University of Parma approved an official document named "University Regulations for the Recognition of Study Periods Abroad" fully compliant with ECTS principles.

This document details the procedures for the recognition of credits, both for study and training purposes.

The University of Parma has been among the "ECTS Label" holders for the period 2009-2013, which confirms that all measures for the recognition of credits have been undertaken and that its quality standards are up-to-date with European ones.

1 ECTS is recognised as 1 national CFU and the recognition procedures imply the adoption of the common tools endorsed at European level:

- a) the Course Catalogue is updated with all variations concerning credits and course contents;
- b) mobility students use the Learning Agreement;
- c) the Transcript of Records is used for credit recognition;
- d) a local grading scale with percentages is available;
- e) graduates receive a DS in two languages.

Each BA proposal implies the reciprocal knowledge of the study programmes. The BA becomes effective only after the approval of the Erasmus Departmental Coordinator. The Coordinator transfers all the data necessary for drafting the agreement to the relevant office. The International Student Exchange Office is in charge of having the BA signed by the legal representatives of the two institutions. Besides promoting new agreements, the Erasmus Departmental Coordinator also monitors the existing agreements over time and in the event of an unsuccessful mobility exchange he/she can decide either to cease or adjust it. Placements are coordinated by the Erasmus Committee of each Department with the support of the International Student Exchange Office, checking the characteristics of the potential host institutions that can sign agreements with the University. The Coordinator assures the coherence with the learning outcomes of the student's degree courses and their professional expectations.

Outgoing students are provided with information and assistance in order to optimise their Erasmus experience. The Office contacts partner institutions and helps mobility students to fill in the application forms. Departmental tutors help outgoing students to plan their academic activities.

Incoming students rely on: a) Help for Erasmus. A program aimed to pair an Erasmus foreign student with a student enrolled at the University of Parma. Our staff matches students according to their faculties, countries and languages, and provides training and tutoring during the entire period. b) Teaching Placement – A programme aimed at introducing students to the Italian school system through coordinated cooperations with secondary school teachers.

The Language Learning Centre (Settore Abilità Linguistiche) provides free courses of Italian language (different levels – QCE) for Erasmus Incoming Students.

Upon arrival, each incoming student carries out a self-evaluation test aimed to identify his/her level of knowledge of Italian and match his/her optimal level for the attendance of the Italian language course.

The recognition of the activities carried out abroad complies with the University Regulations of January 2009. In order to gain full recognition of the didactic activities carried out abroad, students commit themselves by signing the Learning/Training Agreement in the presence of the Departmental Coordinator. The Learning/Training Agreement will be signed by the Departmental Coordinator of the University of Parma, after consulting the various course tutors. On the basis of the Transcript of Records, the Departmental Coordinator will recognize the formative activities carried out abroad according to the Learning Agreement. Finally, the Board of the degree course approves this validation. www.unipr.it

Staff mobility is recognised at both centralised and de-centralised level. At Central level, staff mobility is considered among the relevant activities in the internal research evaluation process. The Board of Evaluators collects data concerning staff mobility to be analysed and then published in the Annual Report. At Departmental level, given the autonomy guaranteed by current legislation for teaching staff management, various forms of formal recognition are in place to favor and promote staff mobility activities, both for teaching and research purposes.

The University of Parma strategically and financially supports participation of teaching staff and students in international cooperation projects.

Department-level Internationalization Committees operate to implement international activities such as international curricula and summer schools.

The University of Parma contributes with its own funds to support and integrate student, teaching and staff mobility, both in Erasmus and in any other Action supported by the Programme.

International cooperation opportunities are actively promoted by the University through its Web Pages, the local press and through the organization of internationalization-focused meetings involving students, teaching and administrative staff.

Original language [EN]

Internationalization figures among the main strategic objectives of the University of Parma. The strategic objectives are approved every three years by the University governing bodies upon analysis of the successful results achieved and the areas of cooperation set as a priority for the reference period. The choice of partners follows different criteria according to their being European or non-European HEIs:

- EU partners are mainly chosen in accordance with quality principles that may ensure adequate support and academic added value to potential mobility students and staff. Peculiar attention is given to academic contents and their transferability in order to facilitate the setup of permanent Erasmus exchanges. Further relevant attention is paid to EU HEIs which may help to guarantee the setting up of cooperative and enduring networks that may increase the cooperation between universities and enterprises so as to foster challenging and innovative opportunities for students at all levels, ranging from the adoption of innovative curricula matching the needs of the labor market to developing placement and training policies that may bring to the successful formation of graduates and PhDs able to meet the standards set by the EU Modernisation Agenda for Higher Education;

- Non-EU partners from industrialized Countries are chosen almost on the same criteria as for the EU ones, with particular attention to the concrete opportunity to start double degrees in the 1st, 2nd and 3rd cycle. The presence of potential university-enterprise cooperations is set as a priority condition to favor the development of interdisciplinary curricula aimed to increase active collaboration with non-EU Countries and create concrete opportunities for research-based collaboration and mutual progress;

- Non-EU partners from non-industrialized Countries (Developing Countries) are selected on the basis of both direct requests for help and cooperation or through the adoption of the strategic guidelines for cooperation with Developing Countries made available by the national government. A University Centre for International Cooperation with Developing Countries (CUCI) is in place, involving nearly all the Departments of the University, and aimed at creating the best conditions for cooperation at all levels with emerging Countries. Activation procedures for new EU and non-EU partnerships may be started at both centralized and Departmental level, in accordance with the specific strategy of the structure in question. After discussing and concur form and contents, each agreement is approved by the governing bodies of the institution. At Erasmus level, the approval of new agreements is subduced to the prior analysis of academic contents and transferability carried out by the Departmental Coordinator in collaboration with the administration offices.

The University has no prejudice about the geographical origin of new partners and is open to any form of structured and feasible cooperation. Current areas of particular interest are Latin America and Asia for the non-EU territories and the Central European Countries for the EU region.

The University recognizes international mobility as a fundamental tool for both the development of cultural and scientific knowledge and the individual's personal and professional growth. Therefore, it is committed to promoting outgoing mobility of students and staff by participating in the most important international mobility Programmes as well as developing stable and successful cooperation relationships with foreign enterprises and HEIs. Main target groups for mobility and exchange activities are second and third cycle students, teaching and research staff and administrative staff, although exchange opportunities for first-cycle students are activated and available.

The development of double/multiple/joint degrees is an institutional priority as well as the progressive introduction of degree courses taught in vehicular language other than Italian (English). Strongly encouraged and supported at national level, this action is aimed at the potential recruitment of international students who are not usually keen on choosing Italy, despite its absolute scientific excellence, as a destination for their academic studies. The University's cooperation activities focused on the development of double degrees and doctorates see the participation of both EU and non-EU partners. Considerable success was achieved through the Atlantis, Tempus and Erasmus Mundus Programmes, that have favored the set up of double degrees, some of these still successfully running after the end of the contractual period. The University encourages and supports participation in these actions both as partner and as coordinating institution. The University portfolio of local, regional and national connections (public authorities, industries, NGOs) available to all EU and non-EU partners to offer a balanced and quality contribution to innovative processes

Original language [EN]

The University's strategy aims to support its participation in all of the cooperation projects implemented under the Programme. The setting up of enduring collaboration networks including both HEIs and enterprises (both SMEs and bigger industries) is aimed to develop an adequate background for the development of initiatives and projects ranging from the credit-based exchange opportunities (both for learning and placement purposes) to the design of innovative and competitive joint/double degrees as well as to the creation of knowledge alliances that may introduce innovation and entrepreneurship.

Directly related to the Programme, the University aims to take advantage of a strong participation in Key Action 1 (student and staff mobility) and Key Action 2 (strategic partnerships, knowledge alliances and capacity building).

Coherently with its strategic guidelines, the University aims to develop a lasting, innovative and competitive background that may help to support the creation of a framework of excellence for mobility and cooperation activities.

In relation to the promotion of a higher attractiveness for both EU and non-EU students, this process is necessarily related to the achievement of two major goals: the development of solid and diversified networks able to provide education and training opportunities based on high standards and the activation of modules, courses and degrees in a vehicular language other than Italian (English). These goals are totally coherent with the national Ministerial guidelines for the 2013-2015 University Development Plan, which represents a significant and harmonised contribution to both National and European expectations.

- Priority 1: Increasing attainment levels

The Programme will help this institution to strengthen all aspects related to the raising of completion rates, as well as widen the participation to university education of non-traditional learners, with main reference to adult learners. Cooperation with EU and non-EU partners will help us to improve the quality of measures related to recognition of prior non-formal and informal learning. Gender, minorities and disadvantaged issues are not referred to, since they already are fully guaranteed at actual status.

- Priority 2: Improving the quality and relevance of higher education

The development of enduring knowledge-based networks, including both HEIs and enterprises, will contribute to the modernisation of curricula and the development of innovative courses and degrees that may more accurately meet the needs of enterprises as well as improve the number of opportunities for lifelong learning, with peculiar attention to measures aimed at upgrading employees' knowledge and skills. The activity of interaction and exchange within the cooperation networks will result in relevant guidelines encouraging the adoption of new forms of flexible education in order to facilitate continuous education and to improve cooperation activities between HEIs and enterprises in the field of education

- Priority 3: Strengthening quality through mobility and cross-border cooperation

This institution has always worked towards introducing ways to remove obstacles to mobility. The awarded ECTS label proves this position. The next challenges are: a) harmonising tools and measures to support intra- and extra-European mobility; b) sharing knowledge and best practices among all partners in view of an adoption of common instruments on a network basis; c) extending knowledge networks to non-European partners encouraging the adoption of flexible mobility schemes; d) adopting a wide use of ICT as a tool for guaranteeing extensive interaction with partner HEIs and enterprises beyond the mobility periods; e) widening the participation of non-university teachers to delivered courses (managers and professionals)

- Priority 4: Knowledge Alliances

The development of KA is among the top priorities of this institution. These alliances will contribute to innovation by increasing collaboration opportunities between HEIs, enterprises and regional authorities, besides encouraging the adoption of innovative teaching methods and a closer cooperation between university and enterprise. Entrepreneurial education schemes deriving from these collaborations will boost the innovation processes at institutional level, contributing to its modernisation

- Priority 5: Improving governance and funding

This HEI aims to develop strategies to increase quality and the efficiency of funding, including performance-based mechanisms, in order to create a virtuous cooperation environment that may take advantage also from financial sources deriving from the public and private sector
